

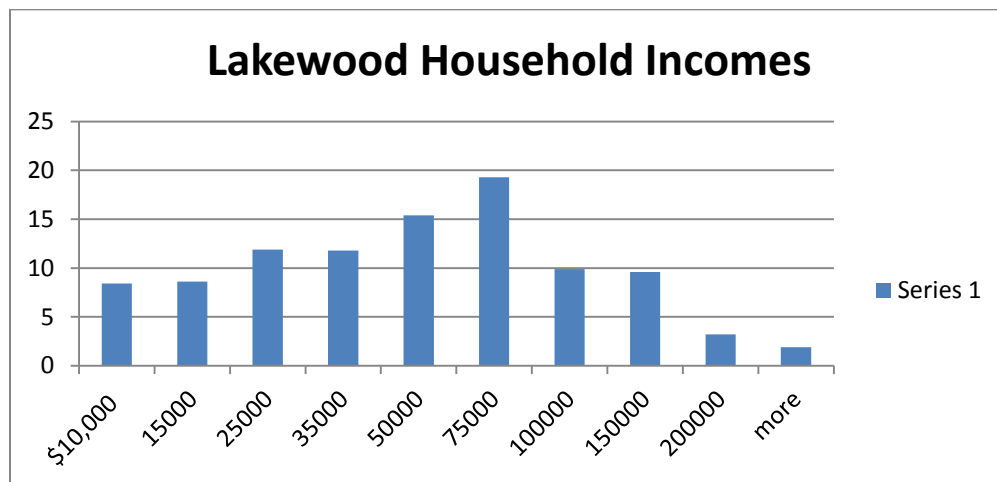
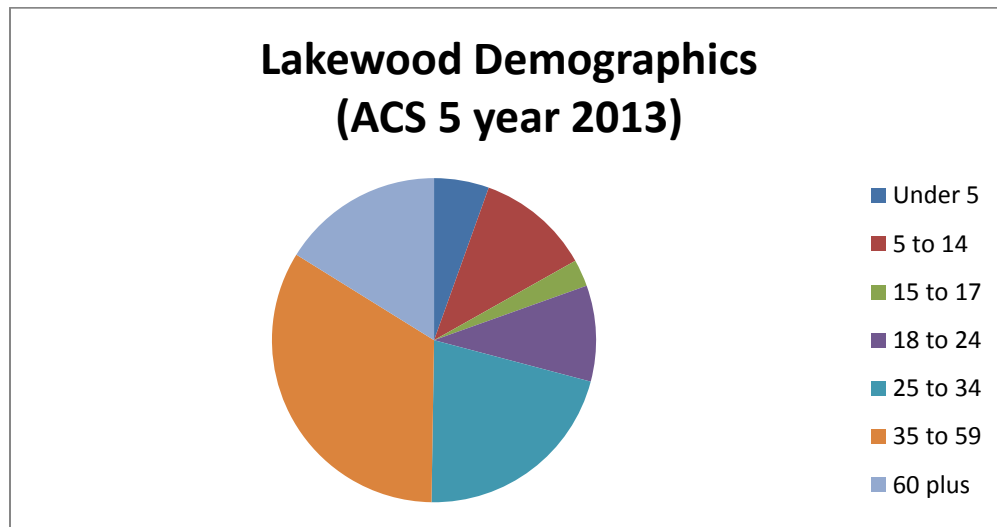
The American Community Survey (ACS): Facts and Graphs

The American Community Survey (ACS) is sent to 1 in 38 households per year. Federal government agencies, states and local communities use these statistics to allocate money. It is a mandatory survey sent to a small percentage of the population on a rotating basis. Individuals can complete the survey online or by paper. Those who don't complete are contacted by a Census staff member.

About 3.5 million addresses are randomly selected each year to participate. The ACS includes questions that are not asked by the 2010 census. The 2010 census used only the short form which asks for age, gender and race. The 2000 census included the long form which includes income information.

51,364 is the population in Lakewood for whom poverty rates can be determined. (This is 329 less than the total population because there is an undetermined population which includes individuals that are institutionalized, living in military group quarters or college dorms and unrelated children under 15, i.e. foster children). Of this population, poverty levels in Lakewood are as follows:

6.5% (3,339) live at less than 50% of poverty
16.4% (8,424) live at less than 100% of poverty
21.9% (11,249) live at less than 125% of poverty

In Lakewood, 10,076 are children under 18 years
9.2% (927) live at less than 50% of poverty
22.8% (2,297) live at less than 100% of poverty
28.5% (2,872) live at less than 125% of poverty

In Lakewood, 5,515 are 65 and over
4.2% (232) live at less than 50% of poverty
13.7% (756) live at less than 100% of poverty
23.5% (1,296) live at less than 125% of poverty
