7. Committee of the Whole Report regarding Resolution to identify Perspective Appointee to the Office of Mayor. (Executive Session May Be Called) (To Be Provided)

Council President Butler stated the following:

The Committee of the Whole which comprises all members of seven members of Council met on November 8 to discuss the vacancy created in the office of the mayor by Mayor FitzGerald's election to the Office of Cuyahoga County Executive. That vacancy will occur on or about January 1, 2011 as I'm sure many of you are aware. The Charter provides that in the event a vacancy occurs in the Office of Mayor the line of succession is as follows; Law Director, Finance Director, Public Works Director, Council President and then an elector of the City of Council's choosing. The Committee of the Whole received news and in fact documentation that all three identified members of the

Administration and the Council President, that being me, declined to accept the role of Mayor on January 1, 2011 when that office becomes vacant. Therefore, it falls upon Council's shoulders to make an appointment for that position. The Council voted unanimously to go into Executive Session, let me explain that. The Members of Council present were myself, Councilman Powers, Councilman Bullock, Councilwoman Madigan and I believe that's it. Councilwoman Antonio has recused herself from these discussions in light of the fact that she will not be actually making the vote in January for the replacement since she'll be down in the State Legislature and because Councilman Summers indicated that he would like to be considered for the vacancy he has also recused himself from these discussions. Councilwoman Smith fortuitously was celebrating the birth of her baby Gabriel and so she was not able to meet that night either.

In Executive Session The Committee of the Whole discussed broadly, generally, whether or not Council would adopt a formal procedure for this appointment. This is a novel appointment in Lakewood's history we don't believe that Council has ever had to choose the mayor in the past from the electorate. Ultimately we did not arrive at a formal process, instead leaving it to individual councilmembers to do their due diligence and determine for themselves what their vote would be and who the person selected would be. The only thing that the Committee of the Whole voted on after we left Executive Session is to refer the manner of the mayoral appointment to the full Council docket this evening and to place a resolution in blank form on the docket tonight in order that we potentially fill in the blank and appoint our prospective mayor this evening. following this communication is a resolution and you'll hear what the resolution says and you'll hear that there's a blank and the blank will have to be filled in in order for us to make known to the public who our appointee would be. Now bear in mind that if we were to take a vote tonight that vote is not cast in cast in stone because on January 1 that's when we have to take the formal vote appointing someone because that's when the office becomes vacant. Things may change it's highly unlikely that they would.

All of that having been said, the Chair will make a motion to receive and file the communication from the Committee of the Whole. Second, by Ms. Madigan.

Mr. Butler added:

We received 12 applications total for the office of Mayor. One of those was from someone who did not live in the City so that application had to be discarded. Also bear in mind that the appointed position is only for actually less than one year. The appointment would begin on January 1 or whenever the appointee would be sworn in in early January and would end on the date of the November, 2011 Municipal Election for Mayor is certified, that's when the appointed term would take place. After which, the elected mayor, the person who is elected November, 2011 would assume the office.

Motion by Mr. Butler, seconded by Ms. Madigan, to receive and file the report. Motion adopted. Five members voting yea Mr. Summers abstaining.

Without objection, the Council President asked that the Resolution be read in full. Council President Butler entertained a motion.

Mr. Powers indicated the following:

Mr. President, I am pleased to move that we amend the resolution by submitting the name Michael P. Summers into the blank. Councilmember Madigan the following:

Mr. Chair, I am happy to second that motion.

Council President Butler indicates the following:

The motion's been made and seconded to amend by inserting the name Michael P. Summers in the blank. Is there any discussion on the motion.

Councilmembers provided the following comments:

Councilmember Bullock: Mr. Chair, I've put careful thought into this vote. It's quite an important one. It's not a vote I've taken lightly, or decided casually, or thought about only in passing. It's a vote that has big public impact, and has an impact that will last at least a year, and perhaps longer.

I also know that for such a matter, the people of Lakewood will want an explanation. And they certainly deserve one. Lakewood voters are thoughtful and committed, and Lakewood citizens are attentive and engaged.

In this vote, Council votes on behalf of the community. Normally when the Mayor is chosen, Lakewood's more than 39,000 registered voters have the opportunity to choose. But if the vacancy proceeds as anticipated, the remaining year of Mayor FitzGerald's term will be filled by we on Council in our capacity as representatives of the people.

So it's important to explain the rationale for my vote, and to share the reasoning that many voters the community might also make, if facing the decision we face tonight.

Some Times call for change, some call for continuity.

Continuity is what these times call for. Lakewood has just weathered a difficult economic storm, and we are now on a solid and improving course. We are not entirely out of difficult waters. We face uncertainty. So it is important that we retain our discipline and stay on our careful course.

What we need is an experienced hand on the tiller. Mike Summers is the right choice. His experience makes him perhaps uniquely qualified to continue the good stewardship we are practicing today.

Council received a dozen applications for Mayor from many Lakewood citizens (and even one non-resident) who all offered sincerity, good intentions, and a diversity of skills from many professional backgrounds. A number of these applicants even have significant community experience in Lakewood, and have demonstrated public service for which I am grateful, and for which the City is a better place.

For me, this is not a close decision, however. The clear choice is Councilman Mike Summers, because of the compelling strength of his experience and because of his demonstrated excellent service.

Mike Summers bring experience not just in the kinds of work required to perform ably as Mayor, but direct experience with the very subject matter of city administration, for he has, of course, uniquely among our applicants been serving as a Lakewood elected official.

In addition, Mike Summers has direct experience with the City's most important issue: the budget crisis. As Finance Committee Chair, Mike led Council through budget deliberations of recent years, and led last month a Lakewood delegation to Moody's in Chicago to present the City's financial credentials. That work was rewarded just last week with the news that Lakewood succeeded in retaining our Aa2 credit rating, which means more affordable financing for city projects and less pressure on taxes.

Mr. Summers experience dates back years ever prior to his service on Council, when he served on the Grow Lakewood Committee that conducted strategic planning for our City.

Mr. Summers' experience even has experience in Lakewood's other major government institution, having served as a School Board member.

Mike Summers is also experienced in business, management, and administration, which are all skills important to a mayor: to partner with business, to directly manage employees, and to administer policies.

Mike Summers has a work style known to be effective and successful. He is analytic, deliberative, and open. He has a good demeanor, and is approachable. When he puts forward an idea, he does his homework and presents a thoughtful case. In Mike, we have a known partner.

Mike Summers knows Lakewood, from years of residency and family life.

And finally Mike Summers share our values and vision. We agree in working to keep Lakewood safe, clean, and family friendly and to ensure the strength of our City in a difficult and changing economy by analyzing our challenges, anticipating and planning for needs, and putting the City on a strategic course to not only survive, but prosper -- to not only continue as a strong community, but to get even better.

The case made be these numerous and compelling reasons, to me is quite clear. And so for these reasons, I will cast my vote in support of Mike Summers as Acting Mayor of Lakewood.

Powers: I have the utmost and deepest respect for our current Mayor, Mr. FitzGerald. He has created many wonderful things in our City. As Councilman Bullock said, continuity is important. I can't imagine anyone who could possibly do as good of a job in the role as mayor, as our current mayor. But I can imagine one person who certainly has a chance to do that. And Mike, I'm pleased to vote for you tonight.

Madigan: Based on my experience working with you, Councilman Summers over the last couple of years I'm happy you put your hat into the ring so to speak and I'm happy to vote for you. I think Tom and Brian summed it up. There's great confidence, most of us who have worked with you or near you have and also I think you bring...to steal a phrase from the County, world optimism. I'm looking forward to the next year of your service.

Council President called the motion; on inserting the name Michael P. Summers:

Mr. Butler made the following comments regarding Resolution No. 8454-10:

I wanted to say a few words about my colleague Councilman Summers -words that serve more to introduce Mike to those outside Ward 3 than ennoble what is his already distinguished reputation. A 1972 graduate of Lakewood High School and the holder of an MBA in management, Councilman Summers is the president and owner of Summers Rubber Company, an eight-facility manufacturing company headquartered on Berea Road. It is a testament to his willingness to serve Lakewood's citizens, and I believe a coup for all of us, that he has agreed to leave the day-to-day running of his company to others while he takes the mayor's chair.

He is widely considered a sage on matters involving job training and development, having served in such prestigious roles as chair of the statewide workforce policy board and president of a group of manufacturing companies dedicated to preserving industrial jobs on Cleveland's westside.

He is also known as an effective manager. Those with whom I've spoken, past employees of his, recall his tough-love approach to running an operation. He has likened the relationship of employee and employer to that of priest and penitent: "Turn your collar backward," he once told the author of a powerful treatise on the blue-collar American workforce, and "deal with [the employees'] issues because they're blocking performance." To be sure, he will bring that overachiever's mindset to bear on Lakewood's 550-employee public company next year, and I am confident our citizens will be the beneficiaries of his abilities.

His civic accomplishments outside the workplace cannot be overlooked and, in fact, make him especially appealing for this vacancy. Councilman Summers was elected to eight years on the Lakewood Board of Education in the 1990s and 2000s. In 2007 he was

swept into his current ward council seat by an eager electorate already taken by his broad appeal. Both before and after his service in elective office, he lent some of Lakewood's most important civic boards and commissions his earnestness and thoughtful approach to problem-solving and planning. On Council, he has been the steadfast and wise chair of our finance committee, playing a critical role -with Mayor FitzGerald and his directors - in our successful shepherding of the annual city budget from the red consistently to the black, and in our crucial efforts to preserve our homes within our city of homes.

Among the applicants for this position were some excellent candidates, each with a unique strength that would serve him well as appointed mayor: local multiple business owner, cheerleader for Lakewood, former health-care executive, political advisor, housing guru -- to a person, all well-meaning, thoughtful and selfless. How fortunate were we, then, to have found an appointee with all of those qualities serving right next to us, willing to accept Council's mandate in 2011, and willing to carry forward the mandate of Lakewood's fortunate citizens into the near future. Congratulations to the next mayor of the City of Lakewood, Councilman Mike Summers.

Summers: First of all to my colleagues on council, I'm very gratified to have this opportunity to serve our citizens in this new capacity. I take this very seriously and will give it everything I've got to make sure our city advances. Happily this vacancy is created in the best and happiest of circumstances where our current mayor has been elevated to a very critical post to our region and I think we all look forward to supporting him in that capacity and certainly as mayor I would look forward to that and doing everything I can to both ease his transition out here so he can get started on his new role which I don't envy in terms of the magnitude and complexity of that assignment. But, I look forward to benefiting mightily from his wisdom and his advice as he departs in this role. And, I am grateful for the transition time. It allows me to get my affairs in order and prepare for the most serious duty that lies ahead. I think we all share a sense of what the potential of Lakewood and ...we look at Lakewood in the next ten years and believe it's going to be a pretty fantastic period for us. Many, many trends favor the Lakewood story and our opportunity is to catch these trends and grab them and leverage them as maximum capacity as we can and draw fully on the resources of the magnificent employees we have. I'm very challenged by this assignment. I can't tell you how much I look forward to it. I thank you for the opportunity.

FitzGerald: First of all I want to compliment City Council first of all on the process that you went through because you did go through a deliberative process and although I'm sure people can find fault with any process, the fact is that in most cities you don't have that. You don't ask for applicants at all. You don't have an interview process. You don't ...it just isn't done that way in most places and you're doing that not just for the mayors position but also for the council position. That is not the norm, I can tell you. I mean, in most cities it is predetermined far in advance and there's no transparency to the process what so ever. First of all my compliments to you on the way you're conducting not just this process but also for the council positions.

I've known Mike for I don't know, 17 years probably when we met in a school board campaign many, many years ago, that both of us lost actually, he really is, probably more than any person in this city, a pillar of the community. He really is. It was reflected in the election in 2007 when he was elected to council where he just won overwhelmingly even though he was running against people running very, very active campaigns. It's because people just know him and they trust him and believe in him and that goes beyond politics. He's not a political person; he's truly a civic servant. I have sought his advice in my three years as mayor, have repeatedly gone to Mike for advice on management decisions and management processes. He really is a manager's manager. He really knows how to do that and he's someone whose advice I've relied on for a long time. The City has a lot to be proud of in terms of what we've done financially and to go from the biggest deficit in the City's history to at the end of this year we'll have our biggest cash reserve that we've had in seven years and we did that at a time when the economy was on its back and our revenues were flat. Mike deserves as much credit for that as any other person in this City. Before he got on Council and his stewardship of the Chairman of the Finance Committee, to follow up on something Councilman Bullock said, it does make sense to have some continuity because even though Lakewood is doing better than it was a couple of years ago by almost any objective measure, it's very fragile. It's been in a fragile balance for a long time. It really can't afford a lot of mistakes. We don't have a lot of room for error because we have significant economic and socioeconomic pressures on the City. So, it's very important we make wise decisions and I think you did this evening. There's some things that I'm going to do that I want to inform you and also Mike about the way that we're going to try to conduct the transition. Some of them parallel what I'm trying to do at the County. One of the things that I asked current County elected officials to do is to refrain from making major personnel decisions, major hirings, major firings, until I got there. We made that same request when I came into office here as Mayor of Lakewood but we're also doing it, I've been doing it really for about the last, really about the last 30 days, I've been holding off on major personnel decisions. Not because anybody asked me to but because I knew if I was successful in the election, I wanted the next mayor to be able to...I wanted to defer as many major decisions as I could especially in personnel. For instance Chief Mroz, this is actually going to be I believe his last council meeting. He's retiring after a very distinguished career and I've intentionally...I could have already appointed his successor and I don't have the intention of doing that. I want Mike to be able to do that since Mike's the person that's going to serve with that person as their Fire Chief and I've done that with a number of other positions as well. Also, in order to ease any kind of transition or make it as seamless as possible, Mike's going to be invited to participate in any of our cabinet meetings, our directors meetings that we have, our regular Monday staff meetings or any other special meetings that we have. As you know we have Citistat meetings fairly regularly. We have about two a week and we're going to continue to have those and Mike is going to be a participant in those when his schedule allows. So, all of that I hope, in addition to the knowledge he already has about how the job works...all that I hope will lead to a very disciplined and seamless transition. That's what I can do to help and will be available for anything that he needs and my congratulations to City Council for making the right choice and my thanks to Mike for accepting it.

Butler: Thank you, Mayor. Any further discussion at this point?

Bullock: I'll say one thing. Mayor FitzGerald I think that's a very prudent and excellent process you just outlined so thanks for being so thoughtful in your exit as in your service.

FitzGerald: One thing I left out too, same thing with any labor union negotiations. We're not going to....One thing that has been an unfortunate thing that has happened, sometimes when an administration is on the way out the door, all of the sudden there's a bunch of, a flurry of last minute legal agreements, union negotiations, and we're going to be briefing him on everything the law department is working on now. So, any of those decisions also we'll make sure he's in agreement with him before we pull the trigger on anything.

Mr. Butler added that it was appropriate at the public meeting to mention that two Council vacancies will now need to be filled. He indicated one was already known, and that now that Councilman Summers is vacating his Ward 3 seat. He indicated that a number of the applicants who sought appointments to the at large are also Ward 3 residents. He indicated that he would treat the applications as valid for both positions. He asked if an extension ten days could be provided. He made close of business, Monday, the 29th as Ward 3 seat applications.
