MINUTES OF THE REGULAR MEETING OF LAKEWOOD CITY COUNCIL HELD IN COUNCIL CHAMBERS 12650 DETROIT AVENUE OCTOBER 17, 2011 7:30 P.M.

Regular Meeting of the Lakewood City Council called to order at 7:30 PM by President Madigan.

Motion by Ms. Madigan, seconded by Mr. Bullock, to excuse the absence of Mr. Powers. Motion adopted. All members present voting yea.

Reading & disposal of the Minutes of the Regular Meeting of Council held October 3, 2011. Motion by Ms. Madigan, seconded by Mr. Bullock, to approve the minutes without the necessity of a reading.

Motion adopted. All members present voting yea.

****OLD BUSINESS****

1. Public Safety Committee Report regarding Ordinances Nos 35-11 and 37-11. (Pg.4)

Motion by Ms. Smith, seconded by Ms. Madigan, to receive and file the report. Motion adopted. All members present voting yea.

2. **ORDINANCE NO. 35-11** - AN ORDINANCE amending Section 506.03 of the Codified Ordinances, Pit Bull Dogs or Canary Dogs; Section 506.08, Alternative Confinement; Section 506.09, Hearing by Director of Public Safety; Notice; Section 506.10, Evidence; Section 506.11, Decision of the Director of Public Safety; and Section 506.13, Disposition of Dangerous Animals, for the purpose of clarifying the definitions and hearing processes related to pit bull dogs, canary dogs, other dangerous dogs and vicious dogs. (**PLEASE SUBSTITUTE** for ORDINANCE 35-11 PLACED ON 1ST READING & REFERRED TO THE PUBLIC SAFETY COMMITTEE 6/20/11, 2nd READING 7/5/11, DEFERRED 7/18/11, RECOMMENDED FOR ADOPTION & REFERRED BACK TO COMMITTEE 9/19/11) (Pg. 35)

Cook Avenue resident indicated the wording of the ordinance; "competent and credible evidence" was not clearly defined and left too much up to the opinion of the animal control officer. (506.10); He referenced the terms, "All pitbull dogs" are deemed dangerous. He said the exceptions being police and service dogs and suggested this was contradictory.

Law Director Butler indicted the reference was 506.03; paragraph A. He indicated the provision remained from 2008 when the original ordinance was enacted. He indicated that 506.14 exception was also in effect. He indicted the general statement shows that All pitbulls are deemed dangerous except those listed 506.14. Law Director Butler indicated the two statements work together as far as interpretation.

Councilmember Smith indicated that the wording, "competent and credible evidence" was discussed in Committee and as to whether this was subjective and asked Law Director Butler to elaborate on the reasoning it general terms would be preferred.

Law Director Butler indicated that the terms "competent and credible evidence" "are used by the Courts when they review the decisions of administrative hearing officers from political subdivisions when those decisions are appealed to the Common Please Court which is the next level of appeal..." Mr. Butler further indicated, "...a hearing officer is able to exclude for example hearsay evidence or other evidence or other evidence that wouldn't meet the test for admissibility in the Court of Law".

Council President Madigan indicated the change benefits the owners position in its clarification as well.

Councilmember Smith added that in reference to excluding certain categories that the recommendation to exclude service dogs came from the Animal Safety and Welfare Advisory Board.

Councilmember Juris indicated that the service dog stipulation was in response to ADA requirements.

The resident indicated there remained no clarification on the word, "predominant" in the ordinance. He indicated he heard 51% was mentioned.

Law Director Butler indicated that more than 50% was defined.

Councilmember Bullock indicated the proposed change is addressing the process in hearings and is not changing anything regarding the original law.

Law Director Butler confirmed that the impetus behind the ordinance was to clarify the due process steps that need to be taken both by the City's standpoint and from of the owner or keeper's standpoint. Her referenced that the current ordinance stating, "an animal may be deemed dangerous with or without a hearing" and that it creates

confusion. He stated that there are different views of what a hearing is; sometimes it is defined as someone looking at the evidence, whether in a public setting or not. He indicated as an example that judges conduct hearings on motions by themselves in their Chambers. He indicated others would assume that a hearing is a public event. He indicated this has been confusing in the past. This is clarified to show that now an inperson hearing is necessary, has to happen within a certain period of time, and a decisions going to happen within a certain period of time, and the decision will be based on competent and credible evidence and decision will be issued within a certain period of time; the decision can also be appealed to a Common Please Court.

Council President Madigan indicated this would be an advantage to the dog owners as well.

Motion by Ms. Madigan, seconded by Mr. Juris, to substitute Ordinance 35-11.
