# #2 Public Works Committee Report regarding Ordinance No. 49-11- Mr. Bullock; Chair.

The Public Works Committee met twice on this proposed ordinance and we concluded just moments ago with a motion to recommend passage tonight of a substitute version of this legislation. The purpose of this legislation is to implement some quality best practices in our ordinances and allow for enforcement of quality best practices for compost heaps in Lakewood by our Litter Control Officer or actually, as the ordinance states, our Public Safety Director or his or her designee so that we can responsibly expand and promote adoption of composting in Lakewood which is a wonderful practice.

It's not only good for my garden and soil building in my yard but the City has an interest to the degree that if we increase composting we can reduce the amount of kitchen waste and yard waste which is wet waste and therefore the heaviest waste that the City diesel trucks away from our households to either a landfill, normally, or our own mulching pile. So, to the degree that this can contribute to reducing our waste stream it's a cost control measure for our City and again this would allow us to what I hope will happen over a period of years is that we greatly expand adoption of composting in a manner then that doesn't create problems for the neighbors. We have seen some isolated cases of unconscientiously composting done by neighbors and this would allow us to address that. So, I will shortly move to suspend the rules and request a substitute but with that I will move to receive and file that oral report.

# #3 Rules & Ordinances Committee Report regarding Ord. No. 63-11 and Resolution 8536-11 – Nowlin

The Rules and Ordinances Committee met this evening. Present were Councilman Anderson, Councilman Bullock, Director Butler, Director Yousefi and Councilman Juris and myself. Before us tonight were two matters. The first was proposed ordinance number 63-11 which proposed to eliminate outmoded language regarding hospitalization coverage for employees. The proposed ordinance deals with a few different changes to the codified ordinances. First, it would combine Lakewood codified ordinance section 149.13 which is salary deductions for hospitalization insurance with Lakewood codified ordinance section 149.14 which is hospitalization coverage for employees. Second, the

definition of eligible employees was updated. Third is the elimination of payment in lieu of hospitalization program found in code section 149.14(e). Fourth, several sections of the ordinance describe administrative finance practices which are no longer utilized, are outdated. We had some good discussion about specifically the elimination of the payment in lieu of hospitalization program and after some discussion the committee unanimously recommended adoption of the ordinance on third reading. Next we discussed proposed resolution 8535-11 which authorizes the City to switch to one or more 457plan representatives of the administrations choosing. 457 Plan is the deferred compensation plan for government employees. The reason being is that it would enable the City to streamline administration, offer additional services to employees and ensure the best representation possible. So, after some discussion about that proposed resolution the committee unanimously recommended adoption of the resolution to full council tonight.
