
2. Update from Human Resources regarding the psychological testing for certain positions.


Mrs. Yousefi reported to the commissioners that as part of the psychological examination the conditional appointees would take a paper and pencil test as well as meet with the Psychologist, Dr. Foerstner after the paper exam was graded. The written exam consists of the MMPI and the PF16. Human Resources has been informed by the company, that the PF16 will no longer be taken as a paper and pencil test but will be administered electronically. Psychological testing is given to police, fire, corrections and dispatch conditional appointees. Both Chiefs are fine with the change. Dr. Foerstner is also in agreement. She reported that there is no change in the test just that it is being administered in a different way. Mrs. Yousefi answered any questions the commissioners had. The commission agrees that testing is taking on a new look and seems to be going in the direction of electronic testing.
