COVID-19 Frequently Asked Questions

07/07/2020

1. Is the office currently opened to the public?

Yes. The office is currently opened to the public Monday through Friday, from 9:00 AM until 4:00 PM.

2. Has the tax year 2019 filing deadline been extended?

Yes. The IRS 2019 tax filing deadline has been extended until July 15, 2020, and so the Lakewood Tax Division has also extended the local filing deadline to July 15, 2020. That said, we encourage everyone to file early if possible.

3. Has the tax year 2019 payment deadline been extended?

Yes. As with the filing deadline, the IRS has extended the 2019 tax payment deadline to the new date of filing—which is July 15, 2020. The Lakewood Tax Division has also extended the 2019 tax payment deadline to July 15, 2020.

4. Have the first (Q1) and second (Q2) quarter 2020 estimate payment deadlines been extended?

Yes. In compliance with the new 2019 tax filing/payment deadline, both the first and second quarter deadlines of 2020's estimate have been extended to July 15, 2020.

5. How can I file and pay my 2019 return?

The City of Lakewood Tax Division offers several remote options for filing and paying your 2019 municipal taxes.

- A) **E-File and E-Pay:** File and pay your return online, no drop off or mailing necessary.

- B) **Short Form:** Need help calculating your Lakewood taxes? Complete our L-1S form, attach required documents per the checklist, and submit to our office (with payment if necessary).
